

Paradigm Works in the Modern Discourse of Economic Theory devoted to the 240 th anniversary of A. Smith's "The Wealth of Nations" and the 80 th anniversary of J. M. Keynes's "The General Theory".

The discussion is encouraged in the following areas:

- role of the paradigm works in the development of economic theory;
- ideological value, philosophical and methodological significance of the works of Adam Smith and John Maynard Keynes: retrospective, modernity and prospects;
- Keynes vs. Smith: ideology of economic liberalism from classics to nonclassics;
- "market and state" dilemma: old and new meanings and evaluation approaches in the heterogeneous background of modern economic theory;
- economic theory and economic reality: from the normative economic theory to economic policy;
- economic welfare of nations through the prism of epochs;
- Adam Smith and John Maynard Keynes as historians of economic science: critical analysis of the development of economic thought;
- orthodox and unorthodox interpretation of Smithianism and Keynesianism in the international and domestic economic science;
- ideological and theoretical heritage of Adam Smith and John Maynard Keynes in the professional teaching of economic disciplines;
- heuristic potential of the classical economic heritage in the modern scientific discourse.

Participants: scholars, teachers, graduate and undergraduate students and all interested parties.

Deadline for papers: September 10, 2016.

The abstract must be no longer than 5 pages of A4 (font – Times New Roman, size – 14, line spacing – 0.5).

Venue: October 6-7, 2016, Faculty of Economics, Taras Shevchenko National University of Kyiv, str. Vasylkivska 90-a, 03022, Kyiv, Ukraine.

Beginning of the roundtable discussion: at 10:00 a.m. on the ground floor of the Economic Faculty, **aud. 101**.

Requirements for participants: please send your papers and application to the email address of the roundtable Organizing Committee **conf_econom_teoriya@ukr.net**.

Your application must be written in accordance with the following criteria:

- write your name and surname as well as the name of the roundtable discussion in the subject of your email;
- in the application indicate the title of your report, your surname and initials, academic degree, academic rank and institution.

Requirements for abstracts: the recommended length of the report is up to 5 pages of printed text.

- 1. Field: 20 mm to the left and right, 20 mm lower and upper field. Paragraph $10\,\text{mm}$.
 - 2. Font: Times New Roman 14, line spacing 1.5.
 - 3. Write the topic of your research, name and title of the author.
- 4. In the upper right corner indicate the initials and surname of the author in bold; with a low-fat font write your academic degree, academic rank and institution.
- 5. After 2 slots in the center indicate the name of the report in bold capital letters.
 - 6. After 2 slots position the abstracts.
 - 7. References are given in the text in square brackets [4, p. 5].
- 8. Number of permitted drawings and tables: 1 unit. Size of pictures: from 60×60 mm to 110×170 mm. Format of pictures: *jpg or *bmp.
- 9. References as well as bibliographic description of sources must be presented at the end of the paper.
